

#### **CRNAs in Missouri and COVID practice waivers**

The year 2020 began as a notable year when Centers for Medicare and Medicaid Services (CMS) Secretary Alex Azar used his authority in the Public Health Service Act to declare a public health emergency due to the 2019 novel Coronavirus. When President Trump declared a national emergency on March 13,2020, CMS responded by imposing blanket waivers affecting many providers. This included waiving the requirements under 42 CFR §482.52(a)(5), §485.639(c) (2), and §416.42 (b)(2) that CRNAs work under the supervision of a physician². This left CRNA supervision to be at the discretion of the hospital and state law. Additionally, CMS waived the requirement for a Medicare patient to be under the care of a physician, so that advanced practitioners can assume patient care and practice under their full scope.

On March 18, 2020, Governor Parson signed Executive Order 20-14, which authorizes executive agencies to waive or suspend certain regulations or statutes, with approval from the Governor's Office, that interfere with the state's response to the spread of COVID-19. This allows agencies to request a waiver or suspension of regulations in an expedited process to help provide immediate health and safety relief. At Missouri State University, we sought to discover what impact these waivers had on Missouri APRNs. A Qualtrics survey link was sent out by the Missouri Board of Nursing to all licensed APRNs. An overall response rate of >800 was further reduced to 670 complete and valid responses. Of these responses, 122 were CRNAs.

When asked about the impact of COVID on our work, 30 CRNAs indicated they had been furloughed from their primary employment. 48 (57%) said their work hours decreased.

CRNA work practices that changed in response to COVID (% of respondents)

Patient scheduling	33%
Infection control	44%

In Missouri, only those CRNAs who practice with a collaborative practice agreement were affected by the Missouri waivers. But it was of interest to see what the responses were to the questions about the impact of COVID.

When the CRNA respondents replied to the question, "Were you aware of the Governor's practice authority waiver?", 72 (59%) were aware. This is notable, since the practice waivers in Missouri did not affect the everyday practice of most CRNAs. Other states did enact waivers that affected CRNAs. States that suspended the in-person supervision requirement included Arizona, Connecticut, Pennsylvania, and Michigan among others.

In response to the question "Where did you first learn about Executive Order 20-04?", 27% (33) CRNAs indicated their professional organization, and 20% (24) by social media. This points out a weakness in our dissemination of practice information. In the face of a pandemic when systems are stressed, there needs to be a reliable and authoritative source for practice information.

Finally, in an optional question, 83 respondents or 68% indicated that they were members of MoANA. This indicates that our sample had a lower proportion of AANA/MoANA members than the national average. Previous studies have indicated that Missouri's non-member percentage = 14% of CRNAs in the state. <sup>3</sup>

Missouri CRNAs were not able to experience waivers of supervision requirement, as in some states. Some of our Missouri APRN colleagues were able to change their practices and we are analyzing our data to quantify that effect. Missouri CRNAs continue to provide cost-effective care and we continue to seek ways to shine a light on our value.



The next National CRNA Week is January 24-30, 2020



In Whats new at MSU?





Another first for our program: on September 19, 2020, we hosted our 23<sup>rd</sup>-Annual Fall Anesthesia Conference in a live, virtual format using Zoom. We had over 100 CRNAs and SRNAs participate in the conference from the safety of their homes. We have also had to transition other program events such as new student orientation and prospective student interviews to virtual formats.

Our SRNAs returned to clinical anesthesia rotations in May 2020. Our SRNAs have not been on the sidelines, rather they have been part of the response. They have learned so much about how to respond to this pandemic and provide new levels of anesthesia care.
