## President's Letter Jean Covillo, CRNA 2017-2018

Hello MoANA Members!

As I write this, I can hear the thunder and lightning crashing outside my window as the fall storms begin to wind up and it reminds me of the speed in which our year together has thundered on by me. It feels like a mere snap of the fingers or a blink of an eye that I nervously took the gavel from Terry Martin last year ...where did it go? What have we accomplished and what does the future have in store? I am sure this is not a new sentiment to presidents of the past. It is a good opportunity to reflect on our accomplishments as an association while thinking about new goals.

When I took office as president my goals were simple, "make Missouri great again." You know I am kidding! But seriously, I wanted to keep our message simple: 1.) Show Missouri who we are; and get CRNA brand awareness out there.

What have we accomplished and what does the future have in store?

Along with brand awareness I added four more priorities; 2.) Maintain a strong defense of our practice by monitoring and interceding when damaging legislation seeking to minimize CRNA scope of practice is presented, 3.) Set MoANA up as the "go to" expert resource for the public, fellow CRNAs, and Hospitals/ASCs when practice issues arise. 4.) Continue to Promote the Education Chair to facilitate powerful educational opportunities through our twice-yearly conferences. 5.) Raise our PAC dollars and promote CRNA-friendly candidates in the upcoming elections.

#### 1.) CRNA Brand Awareness:

This year, PR Chair Austyn Belle Isle and our Board of Directors worked hard to increase public awareness of CRNAs through various PR initiatives. We have created short videos currently displayed at the Hy-Vee gas pumps telling others who we are, other videos shared on social media, and have commenced a program to adopt a highway and start a billboard campaign all to increase our public's awareness of who we are and why we are a crucial participant in the health care arena.

### 2.) Defense—Monitoring Legislation:

This year there were many bills brought forward that, if successful, would have limited Missouri CRNA practice. Our board, our lobbyists, our attorneys, and the AANA reviewed literally hundreds of bills and intervened repeatedly at critical junctures to prevent these bills from passing. This is a critical aspect of our association and cannot be overlooked.

Oftentimes we hear criticism that we aren't advancing our own legislation. However, we can't lose sight of the fact that our profession is constantly under threat every session by the introduction of new bills. It can be as simple as a paragraph that is snuck into another bill seconds before a vote and voted "do pass" before the blink of an eye. This requires constant monitoring by our board and our lobbyists who have done a fine job this year. We have heard that next year may bring new tactics from the Board of Healing Arts relating to potential regulations they would like to see imposed on pain clinics, some of which would require these clinics to be owned in part by a physician. All of these threats will be monitored closely and dealt with as they arise.

#### 3.) MoANA as the Expert Resource:

Over the past few years, we have worked diligently to update our website and make it more responsive to the needs of the public. Facility directors, Hospital Administrators and CRNAs are now visiting and being directed to the site for important information regarding the CRNA scope of practice. Links have been created to get you quickly to the state statutes, rules and regulations, and the nurse practice act as well as the federal requirements through links to CMS rules and regulations. Administrators and CRNAs have been calling upon our Association for answers to practice issue questions and we have been there with the answers and solutions. MoANA is the Expert Resource for any question you might have and this valuable resource is included as part of being a member.

MoANA has obtained formalized legal opinions regarding CRNA scope of practice; interpretation of Missouri statutes and regulations concerning CRNAs working in Hospitals and ASCs. In addition, legal opinions regarding CRNAs working with podiatrists in ASCs have been made available for referral and use when need in private practice. All of these opinions are available to the membership free of charge.

BNDD Issue: MoANA has provided examples of protocols that can be individualized for controlled substance administration when CRNAs are providing anesthesia services while working in non-medically directed settings.


#### 4.) Relevant Continuing Education:



Hello Friends and Colleagues,

This is an incredibly busy time of year for the MOANA Treasurer and this year has been no exception. Currently we are working our way through the final quarter of 2018 with a financial picture that "at this juncture" looks very stable. Additionally, we are budgeting for the entire FY 2019. This involves looking at all the projected expenditures for the coming year. Expenses like: putting on the MOANA spring and MOANA fall educational meetings in 2019, budgeting for lobbying and legislative monitoring in Jefferson City, budgeting for the work done by our committees like Government Relations, Public Relations and Educational committees (all of which are the behind the scenes heroes).

We budget for a portion of the MOANA leadership to attend educational conferences in order to serve you better as an organization. We balance this against our sources of MOANA's income. Our income is derived from a portion of your AANA dues that are sent directly to the states, secondly there is income earned from the attendance of the MOANA spring and fall meetings by the membership, lastly there is interest born of the checking and savings balances.

As your treasurer, I am also tasked with managing the organizations securities which we have invested in a mix of stocks and mutual funds through Central Investments Agency in Jefferson City. I meet with Kevin Callaway, our account manager, once a quarter for an update and we rebalance the organizations portfolio when necessary. Inflation, interest rates continue to creep up slowly which causes market fluctuation in the micro and can cause an occasional pull back ("bear market"), currently looking at a two year window we are still in true "bull market". Our investments returns have been consistent over the course of my two years as treasurer.

Lastly, I have broadened my horizons to aid in MOANA's PAC fundraising. I offered a challenge to all Missouri CRNA's to give a new donation of \$99 or more to the MOANA PAC before August 31<sup>st</sup>. In return I would send them a gold laryngoscope pin for the lapel of their lab jacket, suit coat or name badge.

To date, I have sent out 62 of these gold laryngoscope pins to our members! Your response and your concern for the future of Missouri CRNA's has blown me away! A heart felt "thank you" to all those who stepped up and answered my challenge! I absolutely cannot wait for the October 2018 Fall MOANA meeting in St. Louis to see all the glistening gold laryngoscope pins out there in the audience.

# Committee Reports

### STATE REIMBURSEMENT SPECIALIST'S REPORT

Sheila Ray, DNP, CRNA



Message/Update from AANA President Bruce Weiner 8/21: In early July I wrote to the AANA membership about the latest anti-CRNA activities of Novitas Solutions, a Medicare Administrative Contractor (MAC). At the time, Novitas had just released a final draft local coverage determination (LCD) which, if implemented on August 16 as scheduled, would establish policy that would not recognize nurse anesthesia education and preparation, resulting in denials for CRNA reimbursement for facet joint injections in 11 states, the District of Columbia, the Indian Health Service, and the Department of Veterans Affairs. Worse, the LCD would have a terrible impact on chronic pain patients, especially those in medically underserved areas, who rely on CRNAs to manage their pain and provide quality of life.

Today I am happy to share great news with you about the Novitas LCD!

As of this morning (Aug. 16, the proposed implementation date for the LCD), Novitas has posted an official note on its website stating that it is not going to implement the LCD as anticipated. You can view the LCD and official note <a href="here">here</a>. (Please note that first time visitors to the site need to accept Novitas' terms and conditions before viewing the LCD. Once you accept, you will be directed to the LCD.)

Why, you might ask, did Novitas do a complete about-face less than two months after the final version LCD was released? The answer is simple: The tenacious efforts of the AANA Federal and State Government Affairs staff, staff from other AANA departments, the Board of Directors, and AANA legal counsel made this happen. In particular, our federal advocacy team was instrumental in achieving this result. They tirelessly worked their contacts at the Centers for Medicare & Medicaid Services (CMS), lobbied on Capitol Hill, and exhausted all avenues to exert pressure on Novitas leadership.

It is also important to recognize the contributions of our affiliates, the Council on Accreditation of Nurse Anesthesia Educational Programs (COA) and the National Board for Certification and Recertification of Nurse Anesthetists (NBCRNA), who weighed in on this matter with outstanding letters to Novitas.

Simply stated, the AANA was not going to allow this LCD to take effect without a fight.

However, there is still work to be done. In late August, AANA, NBCRNA, and Novitas leadership will meet in Dallas to begin negotiating a definitive resolution on CRNA reimbursement for pain-management services. During these negotiations, the AANA and NBCRNA will seek provider neutrality for CRNAs and recognition by Novitas of the nonsurgical pain management subspecialty certification (NSPM) as sufficient training for CRNAs to qualify for reimbursement for providing facet-joint injections and other forms of pain management. As always, I will keep you informed of further developments regarding Novitas as they occur.



### MEET OUR NEW STATE PAIN REIMBURSEMENT SPECIALIST!

Wallace Ralston, CRNA, DNP

Wallace Ralston has been a practicing CRNA since 2004. In 2009, he completed his DNP at UMKC and in 2018 completed a fellowship in nonsurgical interventional pain management at TCU. In August 2018, Wallace began UMKCs FNP Program, with an expected completion date of 2020. He is presently a CRNA at Truman Medical Center in Kansas City Missouri. Part of his responsibilities at TMC include being a clinical professor for TMC's School of Nurse Anesthesia. Since 2014, he has chaired three DNP SRNA research projects a year and teaches a Doctoral level epidemiology course in collaboration with UMKC. Wallace also enjoys working in solo CRNA practices in rural Missouri and Kansas several times a month.

Advancing pain reimbursement has become an emerging need as pain management demand and practice has expanded. Several Medicare Administrative Contractors have issued problematic local coverage determinations (LCDs), and some private insurance companies have issued policies that limit or restrict CRNAs from providing pain management services.

Members of the CRNA pain management community recently approached the AANA expressing an interest to proactively address these reimbursement and practice issues by partnering with the state association and the AANA. At the September 9, 2017, Board of Directors Meeting, the Board approved the recommendation to add opportunity for state associations to add a pain reimbursement specialist to their State Reimbursement Specialist (SRS) program.



### What the MoANA PAC Does—and Doesn't Do

The MoANA Political Action Committee or PAC is a familiar name to many CRNAs. Possibly because you were contacted recently and asked for a contribution! Handing over your hard-earned money is never easy; and frankly, it is not especially easy to ask for money either. So what does the PAC do that makes it worthy of your donations? Here is a little info:

### What the MoANA PAC Does

- Helps candidates who are CRNA-friendly and candidates we want to be CRNA-friendly. Missouri has term limits and that means constant turnover and constant campaigns. Campaigns are incredibly expensive. Many candidates simply could not afford to run for office without help from individuals and groups.
- Gives opportunity for lobbyists and CRNAs to educate legislators and candidates about CRNAs and how CRNAs are educated and trained. Legislators come from a variety of backgrounds and relatively few have worked in healthcare. The educational process is an on-going and constant effort.
- Helps CRNAs get involved in politics, when they otherwise do not have the time or interest to get involved. Let's face it: saving lives and giving excellent anesthesia care is more important to CRNAs than following the election throughout the state. That is understandable! Your PAC donations allow you to focus on anesthesia so others can focus on politics and keep you informed.

#### What the PAC Doesn't Do
